Our Mission The mission of the **Racine Community Foundation** is to support the people of **Racine County** by providing funding to **Racine County's hard working nonprofit organizations and students**, and responsibly stewarding our endowment and all gifts entrusted to it, so we may continue to partner with our donors to provide this funding forever.

Those with Little Helping Those with Less

Five thousand miles and an ocean, are protecting us from the most devastating conflict in Europe since WWII. But they can't shut out the pain of watching long lines of exhausted mothers, children and the elderly fleeing cities and villages reduced to rubble. These people are leaving their homeland, the poorest in Europe, for safety. As they pass through communities the war has yet to reach, locals hand them fried sausages, bread, warm drinks, and smiles of encouragement. A reporter described the scene like this: Those with little are helping those with less.

We, as Americans, are fortunate to live in this prosperous country. Our bounty is not equally distributed, nor do most believe that it should be. We know some among us are needy, and we have a long tradition of reaching out to help. The Racine Community Foundation (RCF) has been part of this tradition since 1975. Like every community foundation, we serve a defined geographic area. The RCF cares for the people and communities of the fifth largest county in Wisconsin, extending east and west of Interstate 94.

Three features make us a very special kind of public charity. First, the Racine Community Foundation exists to make our communities better places to live for everyone who calls Racine County home, but we do not offer services directly. Instead, we identify, vet, and support organizations -- on the ground -- that have the knowledge and expertise to fill community needs for: scholarships and educational programs, medical care, mentoring programs, housing programs to address homelessness, arts programs and more. Our competitive grantmaking processes mean efforts are not duplicated, and as a donor, you can be certain that real, legitimate needs have been identified, as have the qualified people to address them.

Second, nonprofits are always challenged by limited resources and limited sources of funding. The Racine Community Foundation gathers gifts small and large and maximizes the impact of each. Invested together, they benefit from economies of scale. Likewise, while a single fund will not be able to satisfy all of the grant requests we receive, many funds together, large and small, get the job done and fill the need.

Third, Racine Community Foundation donors can choose how their gifts will impact the community. You can create a fund designated for a single purpose or multiple purposes. You can create a fund from which you choose a different organization to receive your gift each year. Or, you can have the Foundation's grantmaking committee choose to make that decision based on the requests for funding we receive.

This year, your generosity made possible \$2.7 million in grants. These grants provide services that many desperately need, as well as programs that enrich our communities, making them special, beautiful, and vibrant places for all.

Indeed, those with little can help those with less through the Racine Community Foundation. So can those with much. We are fortunate that you, our generous donors whatever your means, care about our communities and the people in them. Every gift is welcomed and appreciated. Every gift is improving cities, towns and villages throughout Racine County. Every gift is enriching all of us who live here. **Thank you for your generosity.**

List of Funds

The success of the Racine Community Foundation is the result of its responsiveness to the needs of the community – not only as a grant-making organization, or networking resource for other non-profits, but also as a base for those who seek to begin or grow their charitable giving.

The following fund categories are meant to offer flexibility so that you can reach your charitable goals and participate at a level that is right for you.

Administrative Funds Investing in the foundation
These funds provide critical administrative support for the Foundation. A minimum of \$10,000 establishes the fund.

Designated Funds Supporting organizations you care about
These funds ensure long-term annual support for one or more tax-exempt nonprofit organizations. A minimum of \$10,000 establishes the fund.

Field of Interest Funds Aligning your values with high-impact opportunities
These funds give donors the opportunity to provide long-term support to broad areas of interest served by the Foundation. A minimum of \$10,000 establishes the fund.

Named Funds Flexibility to meet changing needs
These funds allow the Foundation unrestricted flexibility to respond to changing and emerging community needs. A minimum of \$5,000 establishes the fund.

Scholarship Funds Investing in student potential
Scholarships help students achieve their educational goals. Donors can help establish scholarship criteria and the Foundation administers the funds. A minimum of \$20,000 establishes the fund.

Acorn Funds Investing in the community
Attractive to many donors, Acorn Funds are built over time with tax-deductible contributions as little as \$50 per month. Fund earnings are reinvested, enhancing tax-free growth until a pre-determined fund level is met and it converts to a grant-making fund.

Donor Advised Funds Personalized giving
Donor-advised funds help donors or their designees play an active role in charitable giving. The foundation retains final discretion regarding distributions, but donors can recommend gifts to their favorite charities. A minimum of \$10,000 establishes the fund.

Organization Endowments
Racine non-profit organizations are turning to the Foundation to manage their financial resources. With a strong investment policy, the Foundation works to maximize investments while also working to provide stable income for use by its community partners. Endowed funds require a minimum of a \$10,000 balance.



Bethany Apartments

The Racine Community Foundation has supported the vital work of Bethany Apartments since 1999. Bethany Apartments provides low cost housing, support and assistance for women and their children who have experienced domestic violence for up to 24 months. To be eligible to stay at Bethany, survivors need to be homeless or at risk of becoming homeless as a result of their involvement in abusive situations. Most of the guests come from the Women's Resource Center, as they can only stay there for up to 30 days. Residents who are provided housing at Bethany also agree to utilize the services and programs that are provided along with case management. Residents use their time at Bethany not only to heal, but also to make goals and get their lives on a different trajectory.

Since November of 1990, 310 women and 460 children have been served. The average age of a resident is 33, and the age range is from 18-67. The average stay at Bethany is 378 days, and Bethany assists the residents with support and other programs to ensure that they are prepared for a safe departure. The ultimate goal is for former residents to be safe and successful on their own.

For the past few years, the Foundation has helped to fund the Resident Employment and Development Program at Bethany. The Program is designed for those residents who are having difficulty finding employment, or have a very limited income to the point where they are looking for ways to earn more money. The Program not only provides additional income, but offers additional training and enhances residents' skills. The residents who benefit

from this Program are typically the most marginalized of the survivors who are served and who have very limited resources available to them. By participating in this, Program residents take much needed initiative to making positive change and develop more self-confidence.

Residents in this Program have the opportunity to provide services in exchange for stipends while developing and practicing new skills. Training and educational programs are offered, housing searches, or programs that assist with home ownership as well. Residents who participate in budgeting and financial literacy programming are also eligible for financial reward. Through this Program Bethany also provides funds for survivors to pursue educational and employment endeavors.

Pam Handrow, Executive Director says the following, "When a resident says that they have a great lead on a new apartment, but they require an application fee and two month's rent, it's great to say I might have a way to help you with that. Suddenly instead of feeling defeated, there is a sense of hope. This program has a lasting impact. It positively affects the future, and bolsters self-esteem. We are grateful!"

Bethany's approach is a holistic and individualized one with the clear intent of setting each resident up for success. The Racine Community Foundation is fortunate to partner with Bethany and know that the work done there is vital for the well-being of their clients and the community as a whole.

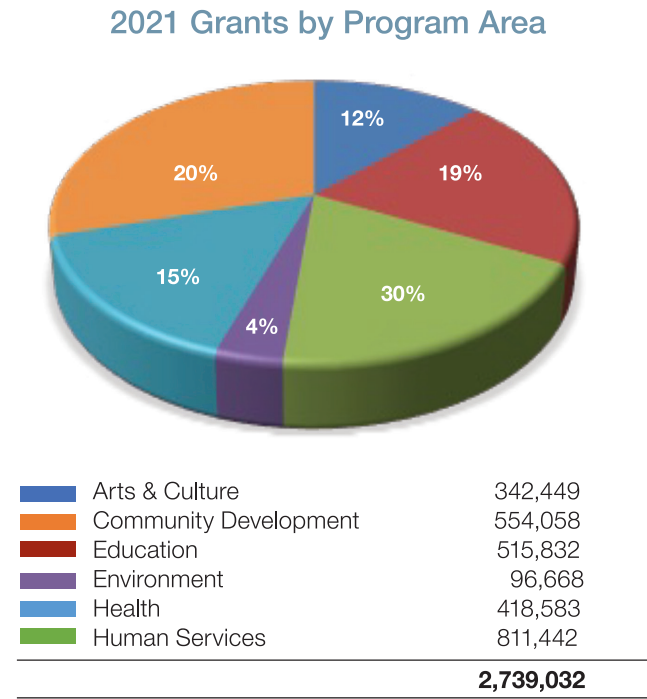
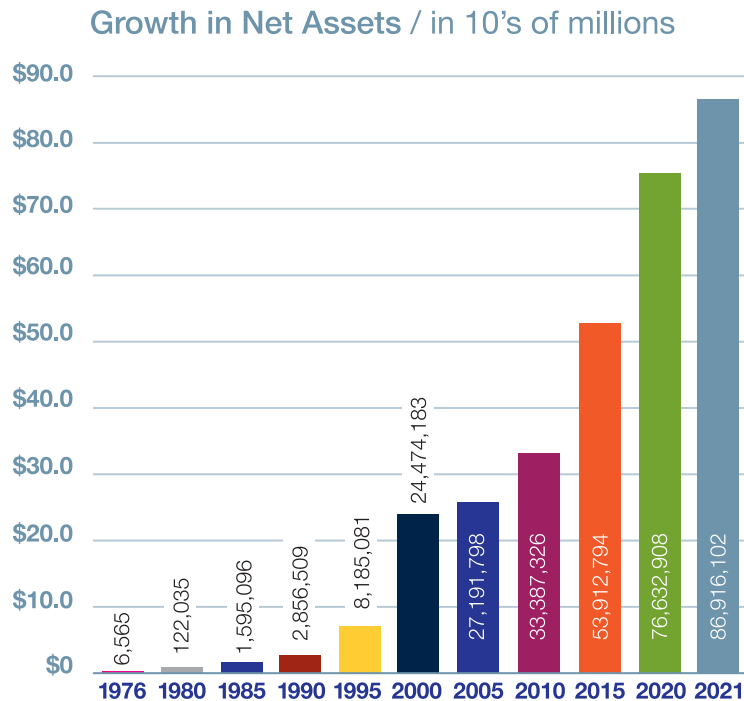


Financial Information for 2021
